## Spotlight Award for July 2014

Tom Prezel is the SURE Spotlight Volunteer for July. He started volunteering for the Montour Trail in 1999 by helping to clear the old Montour Railroad right-of-way that had been abandoned. He volunteered for work parties twice a month to get things ready for a contractor to construct the trail. Once the trail was prepared, the volunteers work twice a month to maintain it.

After retiring in 2006, Tom attended the monthly Engineering and Construction Committee (E&CC) meetings of the Montour Trail Council (MTC) the trail was slowly being built from Coraopolis to Clairton with a total length of the mainline trail of 47 miles. Including the branches, the trail will be 60 miles. Tom worked with the volunteer crews that laid the trail base and the final finished surfaces. He even learned how to operate a large roller that is used to compact the materials that are laid.



Tom has held offices as Co-chair, member of the Board of Directors, and Vice President of the E&CC.

In 2008, he volunteered to take the lead for a bridge project on the Bethel Branch of the trail by representing the MTC as the project manager for the joint Allegheny County and PennDOT's \$1.6 M project. The bridge known as the JR Taylor Memorial Bridge was opened on September 9, 2011. Another bridge, in Library PA will soon be under reconstruction at a cost of \$2.6 M, and is expected to be finished in April 2015.

Tom is now involved in the rehabilitation of the Viaduct in the town of Library, PA. The 506 feet steel bridge was built in 1918 and has been abandoned for about 40 years. Federal Transportation funds were approved in 1993 for the project. After taking over the design in 2011, MTC has now completed the design and is near placing the contract for construction.

Tom joined Westinghouse Bettis Atomic Power Laboratory in December 1967 as an engineer and then became a manager in the Advanced Submarine Project. His work assignments included reactor design and testing for the SEAWOLF submarine and reactor servicing of the ENTERPRISE, the NIMITZ, and two AIW Prototypes surface ships. He also has helped developed methods of fuel disposal for the Naval Reactors Program.

In 1966, Tom married Linda and they have two daughters, a son, and seven grandchildren. They have enjoyed watching the grandkids growing up and attending many of their activities. Tom's also bikes weekly on Pittsburgh area trails with a group that includes Westinghouse retirees.

Tom said, "Volunteering has always given me a sense of accomplishment. It always amazes me at how hard volunteers work to get a job done."

Westinghouse SURE salutes Tom who has donated so much of his time in helping others.

## Varicose Veins Are Treatable

Many people, especially women, experience varicose veins. This condition occurs when tiny valves inside the leg veins are damaged. Blood cannot move efficiently through the vein and back to the heart. Blood then pools and the vein bulges from the strain. Unfortunately, varicose veins are more than just a cosmetic problem; they can become a serious medical situation if a blood clot forms in the vein or if a vein ruptures and leads to excessive bleeding. Accompanying the bluish swollen veins and "spider veins," are tired, aching legs.

A few home remedies can abate the pain and tenderness: Propping feet up. When standing for long periods, gravity works against you and pools the blood in the varicose veins. By propping the feet higher than the hips, the blood has a chance to move out of the legs and return to the heart. Lying on the floor with the legs straight and the feet propped against a wall for a few minutes also helps. Wearing support hose also can prevent blood from pooling; instead it moves into the deep veins for the return trip to the heart. Elastic stockings work on the same principle only more so, but a proper fit is imperative. Wearing low-heeled, comfortable shoes is a must; avoid high heels. Smoking should be stopped. The best thing you can do for your legs is to take them for a walk, especially if you stand or sit for long periods.

A medical procedure, echosclerotherapy, can alleviate most problems, and normal activities can be resumed almost immediately. An ultra sound machine is used to find the deep veins which feed the varicose veins. A tiny tube is inserted into a surface vein and pushed through until it reaches the feeder vein. A tube is used to inject a harmless iodine solution into the vein. The varicose vein collapses and is eventually absorbed into the body. The only side effect is mild, temporary inflammation in the treated leg. Echosclerotherapy, performed in a doctor's office, is less expensive than regular surgery, which is normally done in a hospital.

## The Agony of the Feet

Did you know nails continue to grow no matter what? Fingernails grow at quadruple the rate of toenails. And like hair, the older you get the slower the nails grow. Illness slows growth; nails grow faster in winter. The middle finger nail grows the fastest and thumb nails the slowest. Dominant hand nails grow the fastest.

*Fungus infections* are unsightly. Nails get thick, discolored and form pus causing inflammation of the surrounding tissue. The infection can spread to other nails. *Tinea fungus* causes Athlete's foot; *monoliasis* is a yeast-like infection caused by prolonged use of antibiotics and cortisone.

Buy shoes that fit and are well ventilated. If feet swell, have shoes on had that are a ½ size larger. Wear different shoes each day, and alternate regular shoes with tennis shoes. Wear an adequate size sock, preferably cotton, to protect feet from direct contact with leather. Socks absorb perspiration that causes irritation and swelling. *Corns* are little white, saggy. Perspiration aggravates toes when they rub against one other. Narrow shoes make matters worse. Rubbing alcohol, drying powder, and separating affected toes

with padding will reduce discomfort. Removing corns is dangerous because they often extend deep into the joint of the toe.

*Calluses* are thickened patches of skin located over the bony areas on the fleshy part of the foot. They are the body's way of protecting soft areas from friction and pressure. Calluses can be preceded by blisters. A pumice stone can be used after a soaking if they are not too thick or deep.

*Bunions* are inflamed, swollen areas at the base of the big toe and are hereditary. Often, they must be surgically removed.

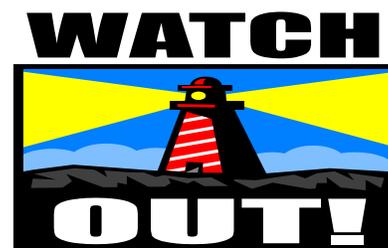
*Ingrown toe-nails* are the painful result of the edge of the nail penetrating the adjoining soft tissue of the toe. Redness, pain, swelling and discharge may develop. Ill-fitting shoes, cutting toe nails too short, flat feet, or excess curvature of the nails can be causes. Feet should be soaked in luke-warm water prior to cutting nails straight across.

### Schemes, Scams and Frauds-- They're Everywhere, Every Day



In 2013, 12.6 million Americans lost their hard earned money to identity theft, investment fraud, and other scams. While the old ones still work, are many new ones dupe the innocent, including seniors. Ben Franklin said, "Distrust and caution are the parents of security." Fraud persists today and requires us to be very careful in our business dealings whether using the phone, debit/credit cards, or an investment adviser or broker. Here is an update about the latest scams:

- ✚ An automated caller advises that a family member has arranged for you to have a medical alert button should you "fall and can't get up." He directs you to dial '1' to connect with the shipping department to complete required paperwork. **DON'T DO IT!** You will pay dearly.
- ✚ Your email in-box notes the Post Office has a package that it can't deliver. You are directed to click on a link for details. **DON'T DO IT!** Your computer will be virus infected.
- ✚ A caller claims he represents Microsoft technical support and he needs to repair a computer issue. He'll want to take remote control of your system to clear it up. **DON'T DO IT!** He can steal your identity and clean out your financial accounts.
- ✚ You browse the Internet social networks out of loneliness or curiosity, and connect. There may be an exchange requiring money with either plane tickets or expenses to meet the person. Many men and women have lost their life savings with this scam.
- ✚ This from an experienced hotel clerk: After midnight a call asks for a specific guest in a specific room. Most hotels require that info from a caller. A crook may garner these details by sitting near the registration desk. Once connected to a drowsy guest the scammer says: "*Ms. Jones, I am sorry to disturb you at this hour, but this is the front desk and we are having lots of trouble with your credit card information in getting your bill paid. I just need you to confirm the card numbers and expiration date and I'm sure that that will fix the problem. I will not call you unless necessary.*" At least two guests at this clerk's hotel had a lot of explaining to do to the credit card company about fraudulent charges.

In the past I've alerted you to a number of common scams that work so well for crooks they are always in vogue: the "Grandparent Scam," the "Missed Jury Duty Scam," the "Foreign Lottery Scam," the "Sweepstakes Scam." Keep them all in mind when you answer the phone or get that tempting notice in the mail.

When I speak to groups, an attendee will tell me that they wish they heard my warnings before that day, as they had been victims. Sometimes, an audience member admits to being scammed and this helps convince people to remain vigilant and follow that "gut" feeling of "If it sounds too good to be true...."

**Suspect or have evidence of identity theft including credit card fraud?** If you are worried about your accounts, because of the increasing amount identity theft news and identity schemes, you can place a **Fraud Alert** on your three credit reports, by calling just one of the three credit bureaus and they will notify the other two. Your **fraud alert** does not cost anything and stays in your file for at least 90 days, and you will receive monthly reports about your credit reports. If you have had an identity theft attempt and filed a report with your police department, you can place an **extended fraud alert**, which will *stay* in your file for seven years. To place either of these alerts, the credit reporting company will require you to provide appropriate proof of your identity, which may include your Social Security number. If you ask for an extended alert, you will have to provide your **identity theft report**. An identity theft report is a copy of the report you filed with a federal, state, or local law enforcement agency when you reported the identity theft or fraud.

**Security Freeze:** You also have the right based on your concerns to place a "security freeze" on your credit report, which will prohibit releasing any information in your credit report without your express authorization, except to those with whom you have an existing account or a collection agency acting on behalf of the existing account. A security freeze is designed to prevent credit, loans, and services from being approved in your name without your consent; however, using a security freeze may interfere with, or prohibit the timely approval of your subsequent requests or applications regarding a new loan, credit, mortgage, insurance, government services or payments, rental housing. You can lift the freeze temporarily to take care of those items. The fee for placing a security freeze on a credit report is \$10.00.

If you are a victim of identity theft and submit a valid police report the fee will be waived. **If you are 65 years or older, in PA the fee will be waived.** To request security freeze, log on [www.experian.com/freeze](http://www.experian.com/freeze) or call **Experian:** 888-397-3742

**Extended date for PA-1000--**That's the PA Dept of Revenue form that provides Property Tax/Rent Rebate program for low income Pennsylvanians age 65 and older and people with disabilities age 18 and older. The

deadline to apply for rebates for property taxes or rent paid in 2013 has been extended from June 30 to Dec. 31, 2014. For property owners the total eligibility annual household income was \$35,000 or less in 2013. For renters it's \$15,000 or less in 2013.

**In September 2014**, the Social Security Administration will resume mailing paper estimated benefit statements to workers between 25 and 60 who haven't signed up to view their statements at [www.socialsecurity.gov/myaccount](http://www.socialsecurity.gov/myaccount) Tell your children and grandchildren about this useful information.

**To reduce your Cellular service or TV service fees--**When you see ads for lower cellular prices, especially from your provider, call and ask for the lower published rate, even if you're locked into a contract and the ad is only for new subscribers. This is reported to work for most folks. Your TV rates going up? Call your provider and say you're **considering discontinuing** their service. You'll be contacted by a customer retention employee and you should be able to get a 15 to 20% discount if you stay.

**IRS Audit?** Even though there are fewer audits, here are two tips that tax attorneys suggest. (1) Ask the IRS to provide a written list of the paper work you should bring to the audit. Agents are required to provide this list upon request. Don't bring any additional paperwork to the audit as that may expand the scope. (2) When answering a question, don't talk beyond answering the specific question, especially when the IRS agent remains quiet for an extended period of time. They use silence as a means to get you to talk about subjects that may expand the scope of the audit.

**Put your car keys with remote beside your bed at night** and you'll have a free built-in alarm system. If you hear strange noises outside or sounds that someone is trying to break into your house, press the "red" button on your remote. The horn honking and flashing car lights will also alert your neighbors and frighten the intruder away. Tell your neighbors about this and suggest they do the same and call 911 if they hear an alarm in the middle of the night. You'll have set up a zero cost neighborhood security system.

**Monday, August 25** Celebrate the National Park Service's 98th birthday. Parks that usually charge admission will waive the fee for the occasion. Visit [www.nps.gov/findapark/feefreeparksbystate.htm](http://www.nps.gov/findapark/feefreeparksbystate.htm) to find a park near you.

**Tax Court ruling goes into effect 1/1/2015--**IRA owners will only be allowed one tax-free rollover every 12 months, even if that owner holds multiple IRAs. A Rollover occurs when IRA money is sent to the owner and then put back by the owner into an IRA with another trustee within 60 days. If you do more rollovers than one in a 12-month period, the Tax Court says all those after the first are taxable distributions and you must pay the tax. IRA trustee-to-trustee transfers are not subject to the 12-month rule because the IRA owner never handles the money.

**Need more body Energy?** Harvard mind-body researcher, H. Benson, MD, found that body energy expenditure dropped by nearly 17% during meditation, and when taking a breath-break. ### Charley Ruch Lifetime Achievement Award

It is likely that no other member of the SURE organization can look upon his body of volunteer work and say to himself “I have made life better for almost all of the nation’s Ex- Prisoners of War.” Our winner is Frank Kravetz, who was badly wounded when his B-17 bomber was attacked during a raid over Germany during WWII. Unable to walk as the result of severe wounds in his legs, Frank’s crewmates wrapped a parachute around his body and threw him out of the ill-fated plane. He landed safely and was taken to a German POW Hospital where he recovered enough to be sent to a concentration camp until the end of



the war. Upon his discharge from the Army, Frank and his wife Anne got involved in the several veterans’ organizations, but he was determined to assist other ex-POWs in filing claims for needed benefits. Frank became a founding member of the American Ex-Prisoners of War organization, and for many years served as its National Director and Service Officer. Frank and Anne Kravetz worked side by side for decades, demonstrating the power of a hard working couple with an excellent idea and the enthusiasm to make it happen. Frank’s Lifetime Achievement Award in Volunteering is inscribed: “To Frank Kravetz, whose lifetime of Service to the American Ex- Prisoners of War Organization has Improved Countless Lives.” Frank’s name has been added to the Lifetime Award Plaque that will hang permanently in the SURE office. The award includes SURE’s check in the amount \$1,000 payable to the SURE served charity of Frank’s choice.
