

20. **PASSENGER MANIFEST:** The group leader is responsible for having a Passenger Manifest on the motorcoach on the day of the trip. The Passenger Manifest must include emergency numbers for all passengers.

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID 19

WAIVER OF LIABILITY: The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and possibly by contact with contaminated surfaces and objects or in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.

Quest Coach cannot prevent you or your customers from becoming exposed to, contracting, or spreading COVID-19 while utilizing Quest Coach's services or premises. It is not possible to prevent against the presence of the disease. Therefore, if you choose to utilize Quest Coach's services and/or enter onto Quest Coach's premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

WAIVER OF LAWSUIT/LIABILITY: I hereby forever release and waive my right to bring suit against Quest Coach and its owners, officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing Quest Coach's services and premises. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

PROOF OF VACCINATION: Some destinations may require passengers to have a vaccination or proof of a negative test. You must be aware of any restrictions and have all appropriate documentation for any destination. You are responsible for understanding all of the requirements and must not rely on Quest Coach to provide this information.
